## LICENCE RENEWAL

Thank you for your renewal fee and supporting financial information. The Authority wishes to advise that your licence has been renewed for the forthcoming year, and a new licence card will be sent to you shortly.

Based on the financial information provided including your Net Tangible Assets, your Allowable Annual Turnover for the year ending **30 June 2014** is **\$12,000,000.00** and your next renewal date will be **27 September 2014**.

Section 35 of the *Queensland Building Services Authority Act 1991* requires you to satisfy the Financial Requirements for Licensing at all times. It is a requirement of the Financial Requirements for Licensing that you cannot exceed your Allowable Annual Turnover by more than 10% during the 12 month period mentioned above without notifying BSA. If at any time you wish to increase your Allowable Annual Turnover by more than 10%, you must first provide BSA with revised financial statements that satisfy the higher activity level.

If your level of Net Tangible Assets, as reported in your licence renewal, decreases by more than 10%, you must notify BSA within one month. Failure to notify BSA is a breach of the Financial Requirements for Licensing, which can result in suspension or cancellation of your licence. Any reduction in Net Tangible Assets automatically reduces your Allowable Annual Turnover in accordance with the formula set out in Note 1 of Table 1 in the Financial Requirements for Licensing.

Failure to notify BSA of either of the above changes to your Net Tangible Assets within the specified timeframe is a breach of the Financial Requirements for Licensing, which can result in suspension or cancellation of your licence. Monitoring your Net Tangible Assets level will help you comply with these conditions.
